Notice Concerning Extraordinary Income and Loss and the Difference From the Last Fiscal Year

As to the financial results for the fiscal year ending March 31,2021 released today, Tokyo Electric Power Company Holdings, Incorporated (hereinafter TEPCO HD) hereby makes a notice concerning extraordinary income and loss and the difference from last fiscal year.

1. Extraordinary Income and Loss

(1)Extraordinary Income

Grants-in-aid from Nuclear Damage Compensation and Decommissioning Facilitation Corporation

TEPCO HD applied for changes in grant amounts based on stipulations in the Nuclear Damage Compensation Facilitation Corporation Act (August 10, 2011, Act No. 94). As a result, it recognized 142.1 billion yen as grants-in-aid from the Nuclear Damage Compensation and Decommissioning Facilitation Corporation

(2)Extraordinary Loss

Expenses for nuclear damage compensations

Based on the Governmental compensation guidelines such as the "Interim Guidelines for the Scope of Nuclear Damage due to the Accident at Fukushima Daiichi and Daini Power Stations" adopted by the Dispute Reconciliation Committee for Nuclear Damage Compensation, TEPCO HD has updated the estimate of its nuclear damage compensations caused by the accident at Fukushima Nuclear Power Stations so far. Thus, 140.7 billion yen, the difference between the revised estimate and the fiscal 2019 estimate, was additionally recorded as the expenses for nuclear damage compensations by the end of the fiscal 2020(In the third consolidated quarter, 95.4 billion yen was recorded as expenses for nuclear damage compensation.).

2. Difference between the annual performance and performance in the last fiscal year

(2) Reason for the difference

Operating revenue fell below last year's revenue due to a decrease in fuel cost adjustments and a decrease in the volume of electricity sold as a result of increased competition and the spread of COVID-19 and other factors.

Operating income and ordinary income fell below last year's levels due to factors such as a decrease in the volume of electricity sold despite Group-wide efforts to continuously cut costs.

Net income attributable to owners of the parent increased compared to last year's due to the reactionary fall in extraordinary loss from the previous fiscal year and other factors.
